Notes for Users

What does the List of Publications contain?

The annual List of Publications comprises all the titles available at the beginning of January 1983. Publications which are out of print or outdated in point of time and as to their content are not listed. They may be consulted at the Federal Statistical Office or in the larger libraries. For a detailed list of sources for major statistical results going further back please see the bibliography of sources of the Statistical Yearbook.

Titles which are expected to appear shortly after the publication of this catalogue are referred to as "in preparation"; publications for which no date of issue can be given as yet, are marked "planned".

All new publications are announced weekly in the "Bundesanzeiger" (Federal Advertiser) and in "Statistischer Wochendienst" (Information on Statistics, Weekly), and monthly in "Wirtschaft und Statistik" (Economics and Statistics). Quarterly updated versions of this List of Publications in the German language will be supplied upon request.

The periodicity is quoted for each publication (see abbreviations page 6). The figures in brackets always indicate the latest edition.

The German edition of the List of Publications contains indications regarding the spatial breakdown of the published material indicating the smallest regional unit shown (e.g. Regierungsbezirk, Kreis; see abbreviations page 6). It should be noted that the next higher units also appear throughout as subtotals or general totals and that not all of the tables have the same degree of regional detail. The data provided in the publications of the Land statistical offices (addresses see page 67) have the most detailed regional breakdown.

How is the publication system classified?

The publications of the Federal Statistical Office may be analysed into the three major groups:

- Summary publications,
- Subject-matter series,
- Classifications.

There are further issued publications dealing with statistics on foreign countries as well as maps and foreign-language publications. An outline of the entire publication system is provided in the schedule on page 2.

The summary publications contain results from several or all fields of activity of the Federal Statistical Office. Besides the "general cross-section publications" offering a com-

prehensive though condensed selection of figures, there are "subject-matter related cross-section publications" which are compiling material for specific spheres (e.g. education, construction, energy) or allocating it to specific groups of persons (e.g. women, children, handicapped persons). There are further "publications on organizational and methodological questions".

Summary brochures - such as the "Statistical Compass", which is published in four languages every year - provide in popular form an outline of important spheres of life as far as they are measurable in figures. They are meant to be first of all information material of a general kind. For hurried readers, the Federal Statistical Office further provides foldovers, such as "Bundesrepublik Deutschland in Zahlen" (Federal Republic of Germany in Figures) and "Was die D-Mark im Ausland wert ist" (What the Deutsche Mark is Worth Abroad). Please enquire for prices charged if greater numbers of copies - also with publicity inserts - are ordered.

The results of individual statistics are issued within the scope of subject-matter series subdivided into large subject fields. Each subject-matter series comprises publication series containing results of continuous statistics supplemented, whenever necessary, by special contributions. The results of censuses/major surveys are issued within the respective subject-matter series as one-time publications.

The classifications constitute subsidiary material for the uniform allocation of data in the statistics and for a breakdown of the results in conformity with the purpose of data collection and presentation. Only in exceptional cases they contain numerical data.

Data from censuses conducted only at greater intervals are to some extent also shown in the form of subject-matter related maps.

The category Statistics of Foreign Countries comprises both cross-section publications and a subject-matter series of its own entitled "Foreign Statistics".

For some of the publications there are also foreign-language editions.

When ordering, please quote not only the title and the periodicity/reference period, but also the code number and - where it is known - the customer's number.

Forwarding conditions

Delivery is made on the account and at the risk of the orderer. Forwarding charges are billed separately (please specify mode of dispatch). Complaints with respect to incorrect or incomplete shipments can be considered only up to 4 weeks after receipt of shipment.

Prices

The prices (value added tax included, without forwarding charges) relate to the position as of 1 January 1983. Prices are subject to alterations. Postage is charged according to the rates of the Federal Postal Administration.

Price abatements for complete annual subscriptions are made only for "Wirtschaft und Statistik" (Economics and Statistics). Quantity discounts are allowed by the publishers for orders of at least 25 copies of a publication. Resellers are granted a trade discount if they make use of the usual order forms (book orders).

Subscription and cancellation

The publications may also be ordered for continuous subscription. Subscriptions for weekly, monthly, quarterly and semi-annual reports will continue automatically unless cancelled at the latest a fortnight after the publication of the issue preceding the last one of a reference year.

Subscriptions for the monthly review "Wirtschaft und Statistik" (Economics and Statistics) may be cancelled only with three months' notice for the end of the year.

Despite the wide range of publications issued by the Federal Statistical Office, it is not possible to publish all the data collected. The reading-rooms of the Library of the Federal Statistical Office in Wiesbaden are open Monday through Friday from 8 a.m. to 3 p.m.

The Federal Statistical Office is issuing annually about 400 press releases on current results of its work. Additional information facilitating the interpretation of statistical figures and relationships is also provided by the monthly press service "Zahlen, Fakten, Trends" (Figures, Facts, Trends). Upon request, this material is supplied free of charge to editorial offices.



The latest figures of the consumer price indices are supplied by an automatic telephone answering service (Tel. 06121/752888). Interested users may inquire about the most recent position of the index of share prices by telex (Telex 4186511 and 4186467) against reimbursement of costs.



As part of the service facilities, the computer-supported Statistical Information System of the Federation (STATIST-BUND) at the Federal Statistical Office is available for users wishing to carry out statistical evaluations or mathematical-statistical analyses. In addition to the compilation of tables

in the desired form, the system also makes possible special processings as well as the application of a great number of procedures of mathematical-statistical analysis and projection. The stock of data, comprising at present more than 170,000 time series, is continuously being updated and extended. The data can also be supplied on magnetic tape. Please direct any inquiries to the Federal Statistical Office in Wiesbaden (Tel. 06121/752426) or to the advisory service "Statistical Information Service" in Bonn (Tel. 0228/332730). Upon request, information material may be obtained free of charge. Against a nominal charge of DM 45.-, it is also possible to obtain from the Federal Statistical Office a catalogue containing about 1,400 definitions of statistical terms used in the Statistical Information System of the Federation (STATIST-BUND).



Participants of the "Bildschirmtext" (interactive videotex) tests in Berlin and Düsseldorf may call up under master page 438 more than 800 pages with statistical tables and graphs, order publications and check with the Federal Statistical Office. Information material may be requested free of charge.
