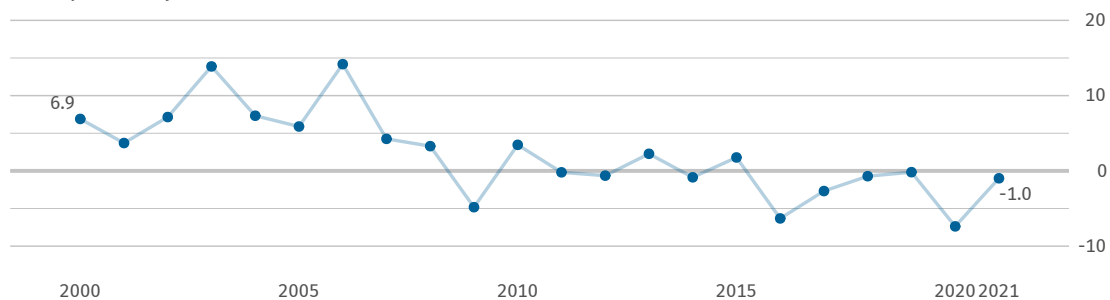

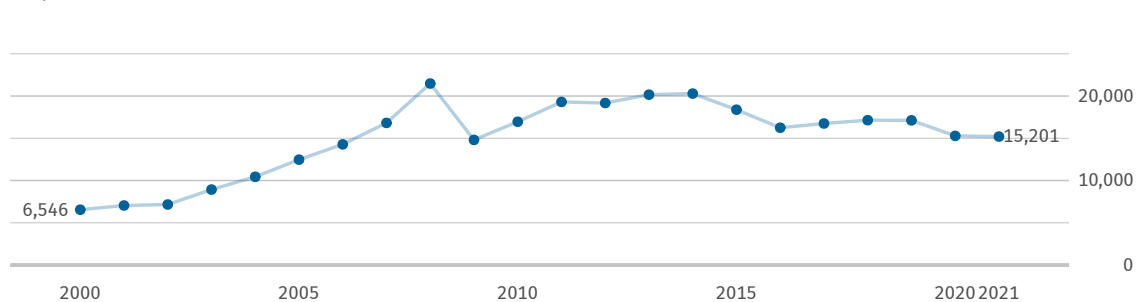

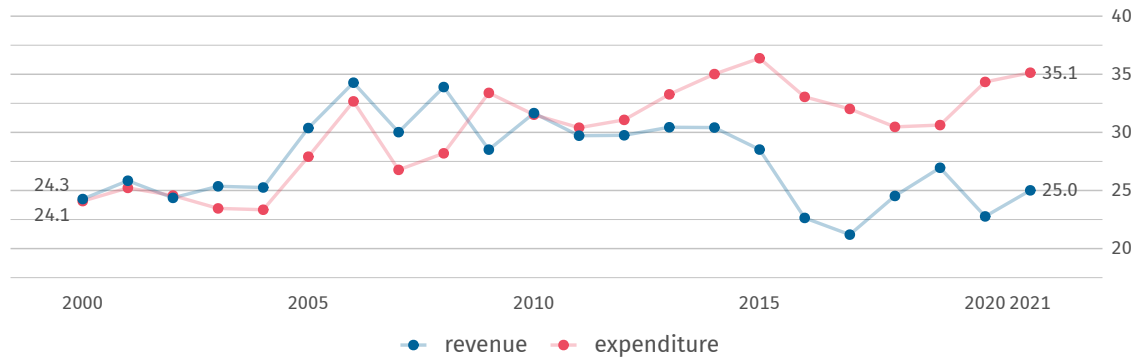

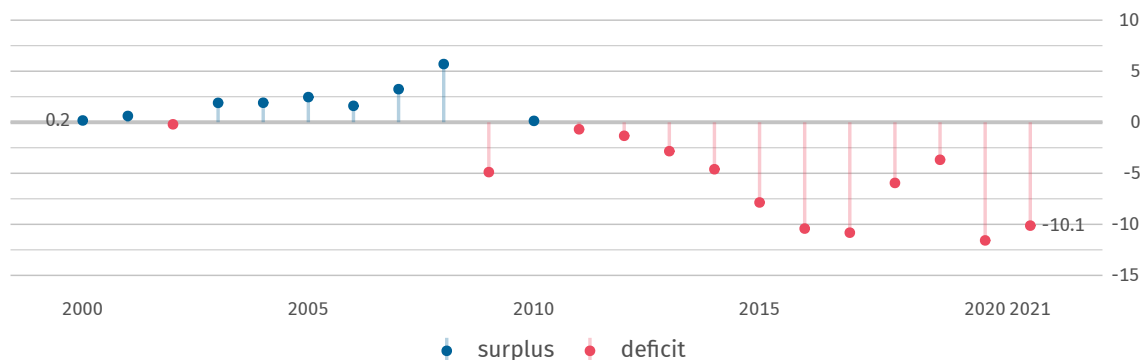
General government revenue and expenditure

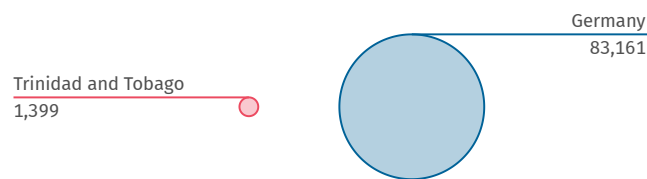

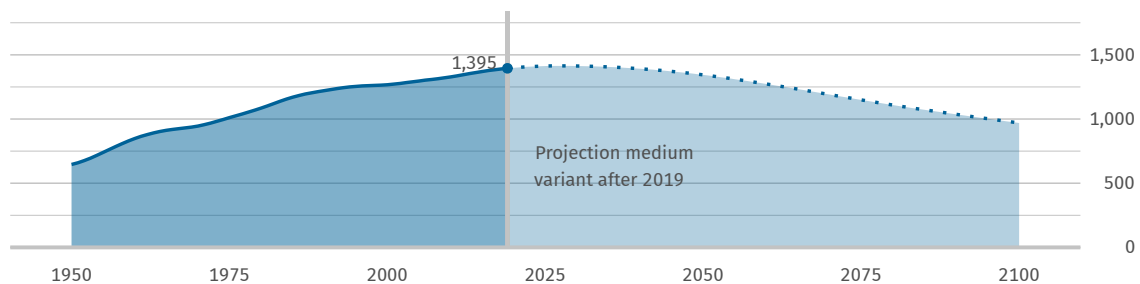

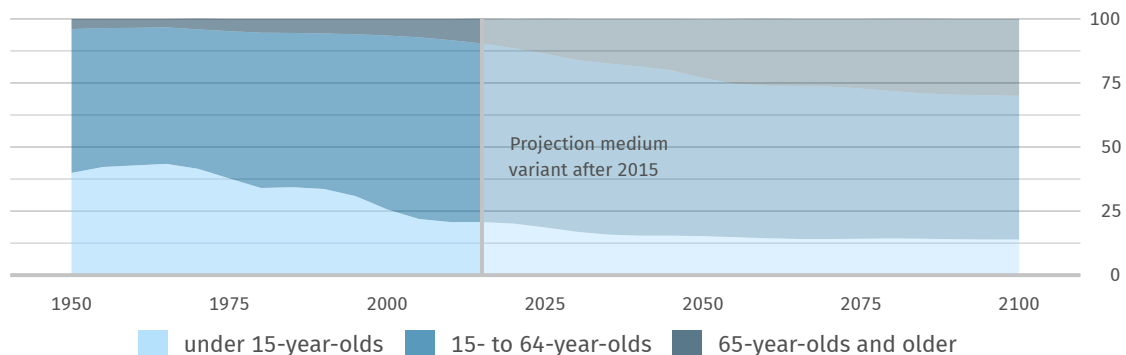

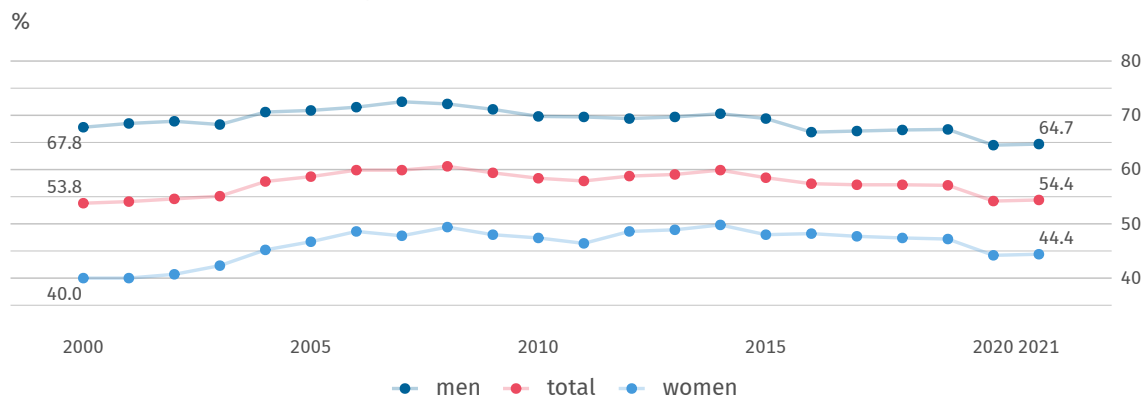

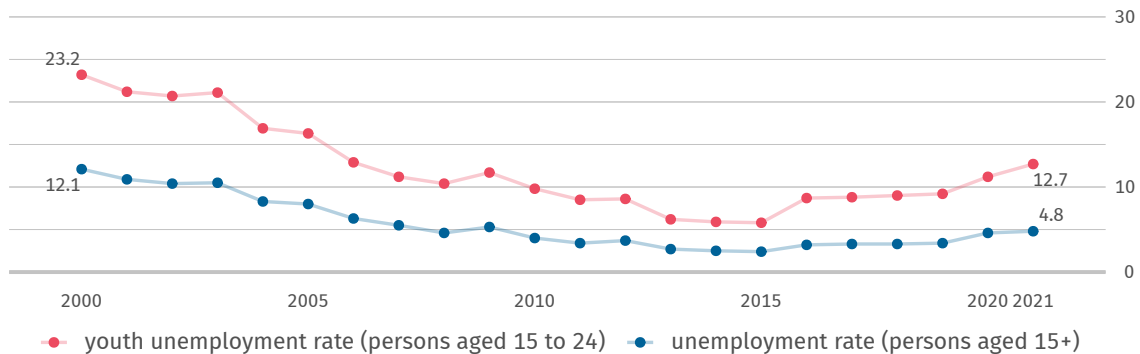

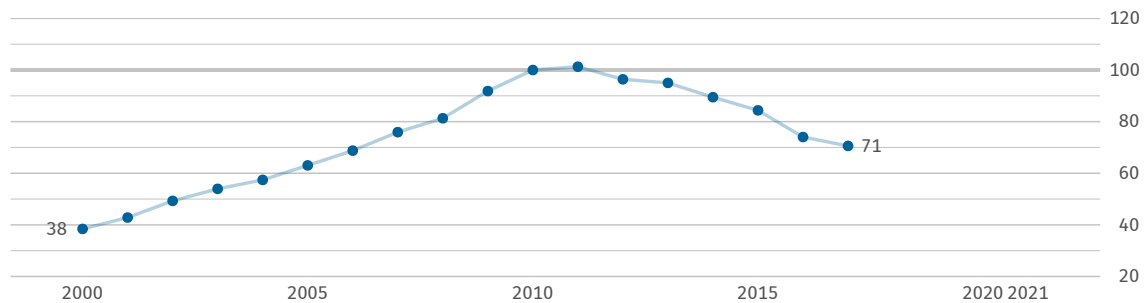

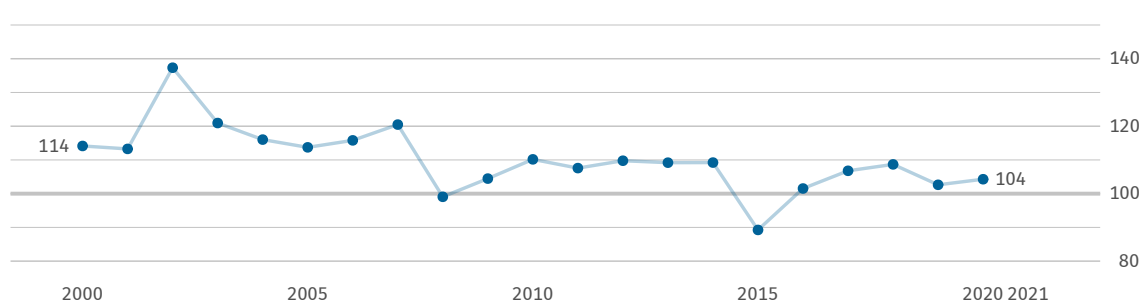

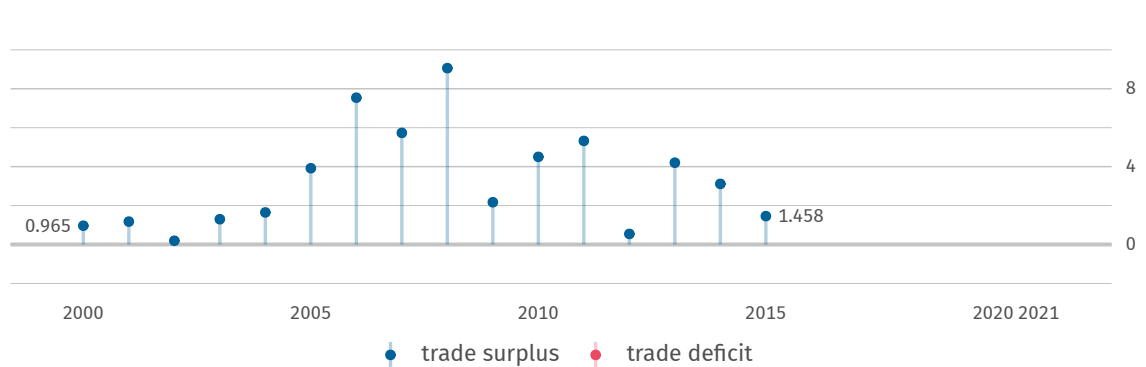

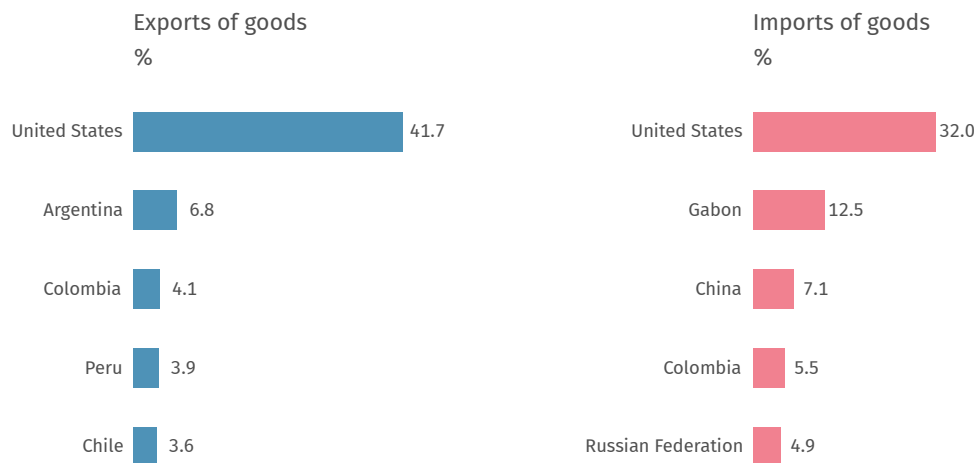

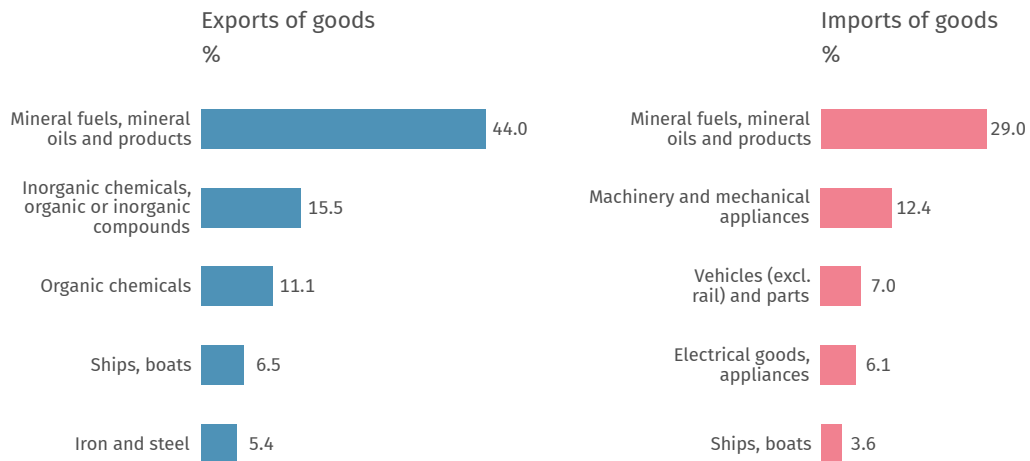

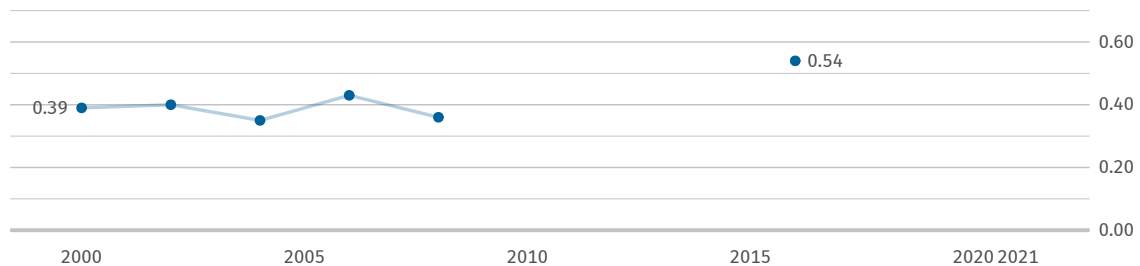

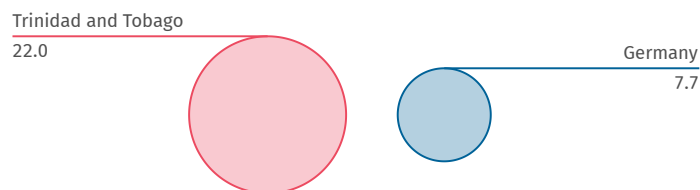

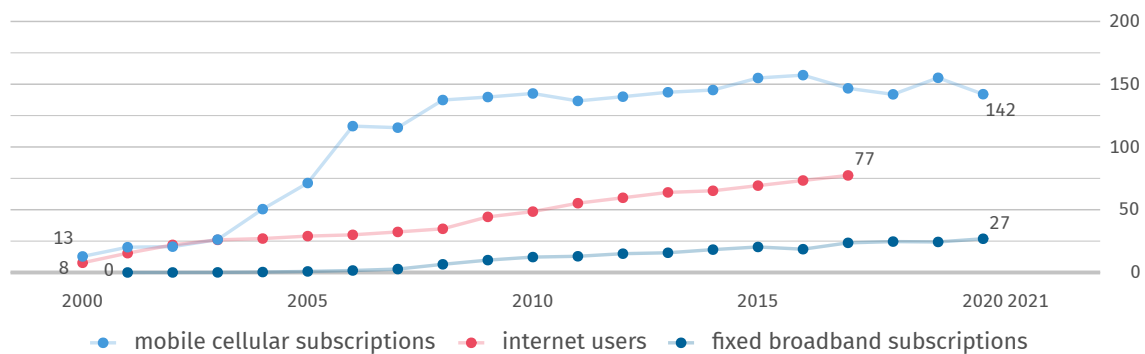
