Notes for Users

What does the List of Publications contain?

The annual List of Publications comprises all the titles available at the beginning of January 1986. They may be consulted at the Federal Statistical Office or in the larger libraries. For a detailed list of sources for major statistical results going further back please see the bibliography of sources of the Statistical Yearbook.

Titles which are expected to appear shortly after the publication of this catalogue are referred to as "in preparation"; publications for which no date of issue can be given as yet, are marked "planned".

All new publications are announced weekly in the "Bundesanzeiger" (Federal Advertiser) and in "Statistischer Wochendienst" (Information on Statistics, Weekly), and monthly in "Wirtschaft und Statistik" (Economics and Statistics).

For the "Summary publications" in the first part of the List, a brief description of their content is given in addition to periodicity, latest issue, volume, format and price.

All other publications are listed in tabular form. The periodicity is shown by an abbreviation (explanations see page 8). The figures in brackets always indicate the latest edition.

The German edition of the List of Publications contains indications regarding the spatial breakdown of the published material indicating the smallest regional unit shown (e.g. Regierungsbezirk, Kreis; see abbreviations page 8). The data provided in the publications of the Land statistical offices (addresses see page 86) have a more detailed regional breakdown.

How is the publication system classified?

The publications of the Federal Statistical Office may be analysed into the three major groups:

- Summary publications,
- Subject-matter series,
- Classifications.

There are further issued maps, publications dealing with statistics on foreign countries and foreign-language publications. An outline of the entire publication system is provided in the schedule on page 2.

The summary publications contain the results from several or all fields of activity of the Federal Statistical Office. Besides the "general cross-section publications" offering a comprehensive though condensed selection of figures,

there are " s u b j e c t - m a t t e r
r e l a t e d c r o s s - s e c t i o n
p u b l i c a t i o n s " which are impart-
ing information for specific spheres (e. g.
education, construction, energy) or allocating
it to specific groups of persons (e. g. women,
young people, foreigners). There are further
" p u b l i c a t i o n s o n o r g a -
n i z a t i o n a l a n d m e t h o d -
o l o g i c a l q u e s t i o n s ".

Reference should be made in this connection
especially to the series of publications
entitled "Forum der Bundesstatistik" (Forum
of Federal Statistics) which the Federal
Statistical Office has created as a platform
for the discussion of major problems of offi-
cial statistics. In addition to experts from
official statistics, the authors to be fea-
tured here will also include experts from
science and research.

S u m m a r y b r o c h u r e s provide in
easily comprehensible form an outline of im-
portant spheres of life. For hurried readers,
the Federal Statistical Office further pro-
vides f o l d e r s . (For details see
page 18).

The results of individual statistics are
issued within the scope of subject-matter
series subdivided into large subject fields.
Each subject-matter series comprises p u b -

l i c a t i o n s e r i e s containing
results of continuous statistics supplemented,
whenever necessary, by special contributions.
The results of censuses/major surveys per-
formed only at larger intervals are issued
within the respective subject-matter series as
n o n - r e c u r r e n t p u b l i c a -
t i o n s .

The classifications constitute subsidia-
material for the uniform allocation of data
in the statistics and for a breakdown of the
results in conformity with the purpose of
data collection and presentation.

Data from censuses are to some extent also
shown in the form of subject-matter related
maps.

The category Statistics of Foreign Countries
comprises cross-section publications with se-
lected figures for a great number of countries
(quarterly reports on foreign statistics)
or data with detailed comments on population
and economy of individual countries (reports
on foreign countries).

For some of the publications there are also
foreign-language editions. The List of Publi-
cations is also available in English and
French.

The publishers also accept advance orders for publications not yet available. Cancellations should be made in writing.

This service will also supply you with general information material concerning the statistical work.

A popular presentation of the work and the results of official statistics is offered by the "Datenreport" (Data Report) the second edition of which was issued in autumn 1985 as part of a series published by the Bundeszentrale für politische Bildung (Federal Centre for Political Education). In Part I the Federal Statistical Office comments on an abundance of facts and figures relating to state, society and economy of the Federal Republic of Germany. Part II, which has been prepared by the special research department 3 of the universities of Frankfurt and Mannheim, analyses the objective living conditions and the subjective well-being of the citizens.

The Federal Statistical Office is issuing annually about 450 press releases on current results of its work. Additional information facilitating the interpretation of statistical figures and relationships is also provided by the monthly press service "Zahlen, Fakten, Trends" (Figures, Facts, Trends). Upon request, this material is supplied free of charge to editorial offices.



The latest figures of the consumer price indices are supplied by an automatic telephone answering service (Tel. 06121/752888). Interested users may inquire about the most recent position of the index of share prices by telex (Telex 4186511 stb d) against reimbursement of costs.



Via "Bildschirmtext" (interactive videotex) - Btx -, a comprehensive information programme of more than 1,000 Btx pages can be called up under the head page *48484#. The essential part is the directory of figures which in easily intelligible tables and graphs provides summary data from virtually all spheres of official statistics. The programme also offers topical headlines relating to current events and a quiz of figures. It is further possible to order publica-

tions and to make brief inquiries by contacting the information service of the Federal Statistical Office.

More than 600 economic indicators may be called up with the flash service for the economy (*484846#). The approx. 60 Btx pages are being updated immediately upon the availability of the most recent statistical figures. To call up one page costs 0.10 DM.

The common programme official statistics (*48481#) is a guide to the information programmes of the statistical offices of the Federation and the Laender to which they are jointly contributing. It permits, among other things, to have direct access to Btx pages of the directory of figures and identical pages of the Land statistical offices, so that it is possible to call up comparable results for the Federal Republic as a whole and the federal Laender. The programme is still being developed. Information material may be requested from the Federal Statistical Office.



As part of the service facilities, the computer-supported Statistical Information System of the Federation (STATIS-BUND) is available for users

wishing to carry out statistical evaluations or mathematical-statistical analyses. In addition to the compilation of tables in the desired form, the system also makes possible

special processings as well as the application of a great number of procedures of mathematical-statistical analysis. The stock of data, comprising at present more than 300,000 time series, is continuously being updated and extended. Users have the possibility to use the information system either via a direct connection or by placing an order with the Federal Statistical Office. The data can be supplied in form of a printout or on magnetic tape.

Online access to a selected part of the time series is also possible via the data processing installations and networks of commercial information providers. Detailed information on access procedures as well as costs may be obtained direct from the firms concerned.

The Statistical Yearbook provides the most comprehensive outline of the figures available from official statistics. About 500,000 data from almost all spheres of economic and social life have made this publication a reference book indispensable for economy, science and administration.

Among others, it provides in clearly arranged form information on number and development of the population, situation on the labour market, production and turnover in the various sectors of the economy, development of wages and prices, level and structure of government revenue and expenditure and the figures of national accounts.

The overall picture is supplemented by comparative data for the German Democratic Republic and a compilation of international figures.

By means of texts, figures and charts, this periodical furnishes the latest information of official statistics on economic and social life in the Federal Republic of Germany.

The text part contains basic articles on questions of the statistical programme, on legal foundations, classifications and statistical methods. Moreover, the results of new statistics and important current surveys are commented.

The essential part of the tables are the Monthly Statistical Figures informing at a glance about major benchmark data and their changes over time. Selected tables are presenting interesting results from statistics which become available in the reference month, and they also provide additional information for the articles.

This publication lends itself especially well for analysing cyclical trends. The original figures and the respective seasonally and calendar-adjusted values are published for major economic indicators and the past 13 months. For longer periods, the development of selected indicators is also illustrated by charts.

In a breakdown by federal Laender, this publication contains selected numerical data from all spheres of official statistics. Its essential part are demographic and economic data; they provide a picture of economic resources of the individual federal Laender. In order to enable long-term comparisons to be made, particular importance was attached to the recording of the development over time - partly since 1950.

(Long-Term Series on the Economic Development)

Periodicity: biennially, latest edition 1984 - 232 pages - Format: DIN A 4 - Price: DM 18.70

Complying with frequent requests for time series going back to 1950, the Federal Statistical Office has issued this publication. Besides the basic figures on population, employment, economy and state, there are also shown percentages, reference figures and indices as well as rates of variance. The selection was chiefly made under aspects of providing numerical data for the assessment of the economic development over a relatively long period of time and for medium and long-term projections.

(Population and Economy, 1872 to 1972)

Published in 1972 - 278 pages - Format: 17 x 25.5 cm - Price: DM 15.- (out of print)

This publication was issued on the occasion of the 100th anniversary of central official statistics in Germany, re-tracing the major phases of work at the statistical offices of the Reich and the Federation. In addition to a comprehensive description of the changes in the programme and the tasks of official statistics since the establishment of the Reich Statistical Office in 1872, there are for users interested in long-term developments a large number of time series containing data from almost all fields of social and economic life, frequently dating back to the 19th century.

(Population Yesterday, Today and Tomorrow)

While the World Population Conferences are discussing the question of how to avoid an "explosion" of the world population, the Federal Republic of Germany is the only country with a deficit of births over more than ten years; since 1974, its total population declined by almost one million. The present volume provides comprehensive information on the structure and development of the population on the territory of what is now the Federal Republic of Germany during the periods 1816 to 1960 and 1961 to 1984, as well as model computations for the future development up to 2030.

(The Position of Women in Family, Occupation and Society)

For more than 30 years, the Federal Statistical Office has presented in special publications at irregular intervals the family, occupational and social situation of women in the Federal Republic of Germany.

As is the case with its predecessors, the present edition contains women-specific data from various fields of official statistics, arranged according to subject fields. Many charts illustrate trends and structures; comprehensive texts facilitate the access to the presented numerical data.

(The Living Conditions of Elderly Persons)

The age structure of the population in the Federal Republic of Germany is characterized by declining birth rates and an increase in the proportion of elderly persons. The overproportionate rise in the number of old persons entails economic and social problems which have been unknown so far.

This compilation of selected data from official statistics provides detailed information on the generation of persons aged over sixty years, on their labour force participation, income, housing conditions and life expectancy.

On the occasion of the United Nations' proclamation of the "International Year of Youth 1985", the Federal Statistical Office for the first time has issued conjointly with the Federal Ministry for Youth, Family Affairs and Health a publication presenting in coherent form the numerical data compiled in various fields of statistics on juveniles and young adults in the Federal Republic of Germany.

The publication, referring as a rule to juveniles and young adults from 15 to under 25 years of age, comprises surveys in tabular form and comments on the subject fields family situation, education, employment, health and health hazards due to the consumption of beverages, tobacco and narcotics, delinquency, social security as well as youth welfare and youth work.

Die Situation der Kinder in der Bundesrepublik Deutschland
(The Situation of the Children in the Federal Republic of Germany)

Published in 1979 - 138 pages - Format: DIN A 4 - Price: DM 15.-

On the occasion of the "International Year of the Child, 1979", the Federal Statistical Office issued this publication comprising data concerning the age group of the young people aged under 15 years.

In subject-related form, statistical data are presented from all spheres of life of the children (e.g. family situation, housing conditions, educational behaviour, leisure time activities). Frequently comparative figures for former years are shown. Major benchmark data are presented in a regional analysis by federal Laender and in part also in international comparison. The individual chapters each comprise a detailed table part preceded by methodological explanations, source references and concise comments.

(Structural Data on Foreigners in the Federal Republic of Germany)

Information on the number and living conditions of the foreigners in the Federal Republic of Germany are meeting with growing interest of the general public. This induced the Federal Statistical Office to compile the data on foreigners existing in numerous publications of the various statistical subject fields into one volume and thus to make them more readily available to the interested reader. Wherever this was possible, the data on foreigners have been opposed to the corresponding figures for the German or the total population for purposes of comparison. Comprehensive comments and numerous graphs are facilitating the access to the numerical data presented.

On the occasion of the "International Year of the Handicapped, 1981", the Federal Statistical Office compiled comprehensive statistical data on this group of persons.

This publication not only deals in great detail with the nature, extent and cause of the disablement, but also with rehabilitation measures, facilities for handicapped persons, accidents and newborns with malformations discernible at birth. In addition to detailed tables, the individual chapters also contain summaries of the results, conceptional and methodological explanations as well as graphs on major trends and structures.

(Education in Figures)

This cross-section publication compiles in concise and clearly arranged form the statistical material available concerning the various partial fields of education. The main point of emphasis are data on pupils at schools of general education and occupational training, apprentices and students. The presentation is preceded by population and employment figures analysed by age as important reference values. Data on pre-school and further education, public expenditure on education and science as well as educational promotion and some international tables are rounding off this report.

(Housing Conditions in the Federal Republic of Germany)

This brochure offers in clearly arranged form an outline of the structure of the housing stock and housing supply in the Federal Republic of Germany in the light of the results of the 1 % housing sample survey of 1978.

In addition to structural data on buildings and housing units, the publication provides information on the housing situation of the households and individual groups of the population (e.g. elderly persons, foreigners). The brochure is complemented by data on the recipients of housing allowances.

Readers wishing to get informed about the economic events in the Federal Republic of Germany will find in this publication reliable and easily comprehensible data.

After basic statements concerning the development and structure of the economy as a whole, the main part of the volume deals with the individual economic sectors. There are presented in each case the bases of production (enterprises, persons employed, plant, energy and raw material supply, etc.), the production of goods and services and the sales of the goods on the market. Various graphs are illustrating the texts and the numerical data shown.

Figures on the construction industry are compiled for this publication from various statistical sources and presented in user-oriented form. The emphasis is on data from the construction reports (e.g. persons employed, turnover, orders received and at hand) as well as from statistics of building activity (work authorized and work completed). This is supplemented by selected results of other statistics (among others, price statistics, wage statistics, labour market statistics) which also provide information on the construction industry. This permits to get an overview of the entire sector and at the same time enables to the greatest possible extent the complete coverage of building activity from the input of the production factors to the finished structure.

The discussions on the pollution load due to the consumption of energy have further increased the interest in well-considered information.

This publication provides topical data on power production. For the various sources of energy are shown data on supply, utilization, imports and exports, price indices and prices as well as establishments, employment and production indices.

The core of this reference volume is a uniformly arranged catalogue of all federal statistics showing the wide range and multiplicity of the statistical programme.

An introductory text part presents in summary form the objectives, bases, methods and results of statistical work. The Annex comprises important reference material (e.g. the legal foundations of federal statistics, the classifications used, calculation bases of indexes) and supplementary schedules (e.g. on publications).

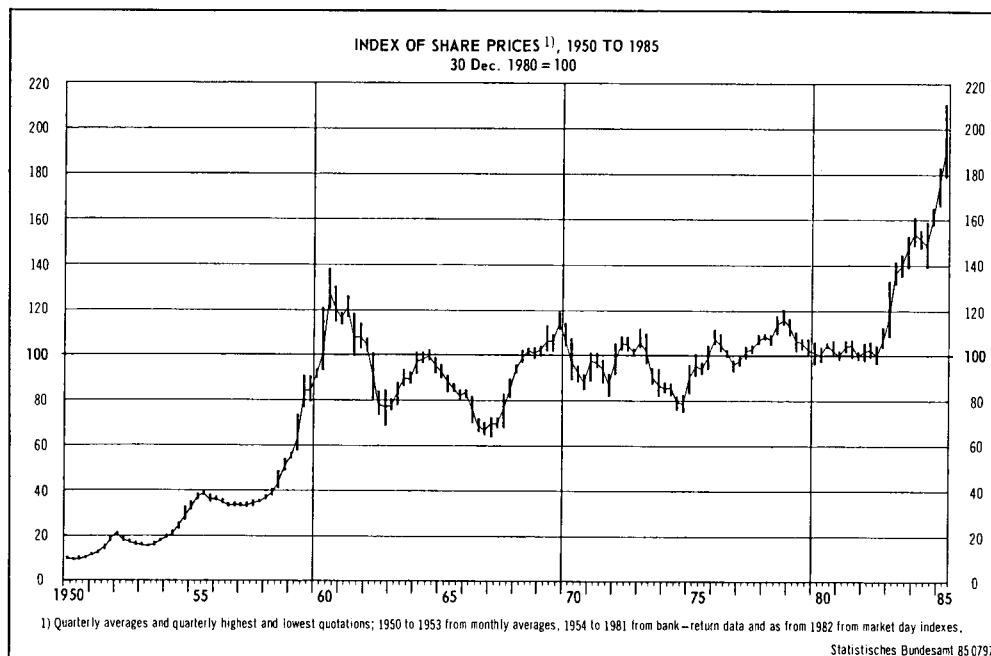

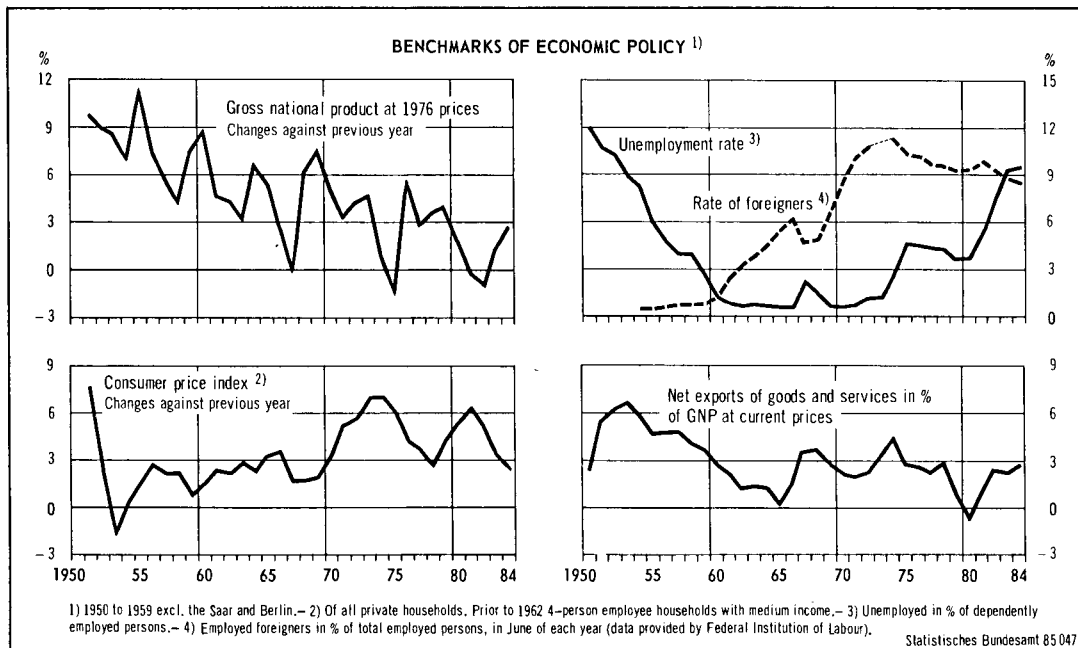

With this publication the Federal Statistical Office presents comprehensive and fully comparable results of national accounts for the years since 1950. It thus provides the major data concerning the long-term economic development in the Federal Republic of Germany over the past 35 years.

The publication shows in an impressive way the economic recovery in the Federal Republic after World War II: In 1984 the gross national product at current prices was seventeen times as high as in 1950; at constant prices it rose to just under five times and per capita to almost four times the 1950 value.

The economic growth however did not proceed evenly. During the reconstruction phase of the 1950s the real growth was 8.2 %, in the 1960s (which were years of full employment) 4.6 %, in the 1970s (which brought the energy crisis and commencing structural problems) still 2.8 %, and in the years 1980 to 1984 with high unemployment only 0.7 % in the yearly average. A slight recovery of the economic development was however observed in 1984.

Information is also provided on the growth of production in the individual sectors of the economy, on the development of the production factors labour and capital, on the investment activity and foreign trade, on the development of incomes as well as the rising level of supply and the saving capability of the population.
