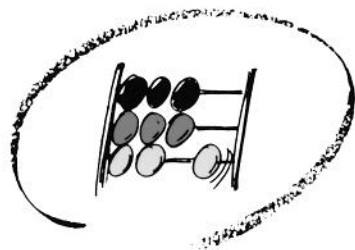
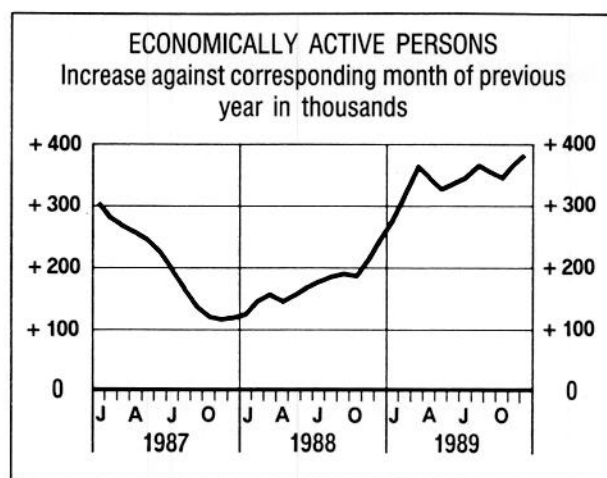

What does the List of Publications contain?

The annual List of Publications comprises all the titles available at the beginning of January 1990. They may be consulted at the Federal Statistical Office or in the larger libraries. For detailed lists of the sources of major statistical results going further back please see the bibliographies of sources of the Statistical Yearbooks.

Titles which are expected to appear shortly after the publication of this List are referred to as "in preparation"; publications for which no date of issue can be given as yet are marked "planned".

All new publications are announced weekly in the "Bundesanzeiger" (Federal Advertiser), in "Statistischer Wochendienst" (Information on Statistics, Weekly), and monthly in "Wirtschaft und Statistik" (Economy and Statistics).

For the "Summary publications" in the first part of the List, a brief description of their content is given in addition to periodicity, latest issue, volume, format and price.

All other publications are listed in tabular form. The periodicity is shown by an abbreviation (explanations see page 4). The figures in brackets always indicate the latest edition.

The German edition of the List of Publications contains indications regarding the spatial breakdown of the published material, indicating the smallest regional unit shown (e.g. Regierungszirk, Kreis). The data provided in the publications of the statistical offices of the Länder (addresses see page 81, 82) have a more detailed regional breakdown.

How is the publication system classified?

The publications of the Federal Statistical Office may be analysed into the three major groups:

- Summary publications,
- Subject-matter series,
- Classifications.

There are further issued maps, publications dealing with statistics of foreign countries and foreign-language publications. An outline of the entire publication system is provided in the schedule on page 2.

The **summary publications** contain the results from several or all fields of activity of the Federal Statistical Office. Besides the general cross-section publications offering a comprehensive though condensed selection of figures, there are subject-matter related cross-section publications which are imparting information on specific spheres (e.g. education, construction, energy) or allocating it to specific groups of persons (e.g. women, young people, foreigners).

There are further publications on organizational and methodological questions. Reference should be made in this connection especially to the series of publications entitled "Forum der Bundesstatistik" (Forum of Federal Statistics) which the Federal Statistical Office has created as a platform for the discussion of major problems of official statistics. In addition to experts from official statistics, the authors to be featured here will also include experts from science and research.

Summary brochures provide in easily comprehensible form an outline of important spheres of life.

The results of individual statistics are issued within the scope of **subject-matter series** subdivided into large subject fields. Each subject-matter series comprises publication series containing results of continuous statistics supplemented, whenever necessary, by special contributions. The results of censuses/major surveys performed only at larger intervals are issued within the respective subject-matter series as non-recurrent publications.

The **classifications** constitute subsidiary material for the uniform allocation of data in the statistics and for a breakdown of the results in conformity with the purpose of data collection and presentation.

Data from censuses are to some extent also shown in the form of subject-matter related **maps**.

The category **Statistics of Foreign Countries** comprises cross-section publications with selected figures for a great number of countries (Statistical Yearbook for Foreign Countries, quarterly reports on foreign statistics) or data with detailed comments on population and economy of individual countries (reports on foreign countries).

The publications of the Federal Statistical Office as a rule are issued in the German language. In exceptional cases, there are however also **foreign-language editions**. The List of Publications is also available in German and French.

The Statistical Yearbook provides the most comprehensive outline of the figures available from official statistics. About 500,000 data from almost all spheres of economic and social life have made this publication a reference book indispensable for economy, science and administration.

Among others, it provides in clearly arranged form information on number and development of the population, situation on the labour market, production and turnover in the various sectors of the economy, development of wages and prices, level and structure of government revenue and expenditure and the figures of national accounts.

The overall picture is supplemented by comparative data for the German Democratic Republic and a compilation of international figures.

For readers interested in history, statistical documents from former periods have been presented in a supplement since 1986.

Detailed information and data on the economic and social life in almost all countries of the world are included to complete the overall picture (see also the advertisement on the back cover of this List).

The essential part of the tables are the Monthly Statistical Figures informing at a glance about major benchmark data and their changes over time. Selected tables are presenting interesting results from statistics which become available in the reference month, and they also provide additional information for the articles.

The selection was chiefly made under aspects of providing numerical data for the assessment of the economic development over a relatively long period of time and for medium and long-term projections.

In addition to a comprehensive description of the changes in the programme and the tasks of official statistics since the establishment of the Reich Statistical Office in 1872, it contains for users interested in long-term developments a large number of time series comprising data from almost all fields of social and economic life, frequently dating back to the 19th century. This makes the volume a valuable source of information far beyond the year of its publication.

This book is designed to present prints and figures, not to show political relationships or economic theses, but to look into the day-to-day life of ordinary men and women. Do you remember what a hard job housework used to be still some decades ago and with how little ordinary people had to make do? Have the technological and economic developments of half a century made things easier for the average citizen, did they relieve him/her from burdens and constraints, or did they make people dependent?

The photographs show our way of life as it was, how it developed and as it is today, and the figures recorded are illustrated by graphs. The publication sets out 40 years of life in the Federal Republic of Germany, 40 years of economic and technological change. It is meant to entertain and inform and to create a vivid impression of the changes in our everyday life (see also the advertisement on the back cover).

The publication, referring as a rule to juveniles and young adults from 15 to under 25 years of age, comprises surveys in tabular form and comments on the following subject fields: Family situation, education, employment, health and health hazards due to the consumption of beverages, tobacco and narcotics, delinquency, social security as well as youth welfare and youth work.

The individual chapters each comprise a detailed table part preceded by methodological explanations, source reference and concise comments.

In addition to the publishers' programme (page 5 ff.), the Federal Statistical Office issues a number of **brochures, information services,**

working papers and folders which are provided to interested readers either free of charge or against a small nominal fee. (For an overview see the list on page 63).

A brief outline of the tasks and the working methods of the Federal Statistical Office as well as of the services citizens may expect of the Office is provided by the brochure *Bundesstatistik – für wen und wofür?* This brochure was also published in the English language under the title "Federal Statistics – Users and Purposes".

For users without any previous special knowledge, the four numbers of *Informationen über die Bundesstatistik* (Information on Federal Statistics) show in concise form what information is covered for federal statistics in what way and on the basis of which legal foundations, what purpose the surveys serve and where the results are being published.

Special informational brochures are also being published for selected subjects. They describe the legal and methodological foundations of the statistics, provide an outline of the survey and processing procedures and extensively present the current offer of publications.

Methodological problems are discussed in the publication series *Ausgewählte Arbeitsunterlagen zur Bundesstatistik* (Selected Working Papers on Federal Statistics). This series exclusively comprises working papers compiled by staff members of the Office on conceptual, methodological and technical-organizational problems.

For empirically working economic and social scientists who are interested in methodological questions, there is also available the information service *Methoden . . . Verfahren . . . Entwicklungen* which deals with questions concerning the methods and procedures of statistical surveys. The English edition with the title "Methods . . . Approaches . . . Developments" includes also selected contributions from the monthly review „Wirtschaft und Statistik“ (Economy and Statistics).

For hurried readers, the Federal Statistical Office further provides folders by which major basic statistical data are available to users at a glance.

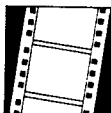


In about 450 **press releases** yearly, the Federal Statistical Office informs about the most recent results of its work.

Particularly noteworthy data that are of interest to a large public are highlighted as the **Zahl der Woche** (Figure of the Week).

Definitions and explanations of basic statistical terms as well as of statistical methods and procedures are provided by the semimonthly press service **Statistik von A-Z** (Statistics from A-Z).

The monthly press service **Zahlen Fakten Trends** (Figures Facts Trends) is an article service providing statistical results presented in a journalistic manner and illustrated by charts.



For citizens who would like to gain an insight into the production, the importance, the use and the dissemination of statistics or who are interested in the results of official statistics, there is a **film** now: "Rechnung ohne Unbekannte - ein Amt stellt sich vor" (Calculation Without Unknown Quantities - an Office Presents Itself). This video film (on VHS cassette, in colour, length: 16 minutes) may be borrowed free of charge from the film services of the **Laender**. For further information about the film and for the addresses of the distributing offices please see the folder available free of charge at the Federal Statistical Office.



Via "**Bildschirmtext**" (interactive videotex) - **Btx** -, a comprehensive information programme of more than 1,000 Btx pages is presented starting main page * 48484 #. The central part is the compendium of figures which in easily intelligible tables and graphs provides summary statistical data. Included are data from all spheres of official statistics, from the demographic development to the latest results of the national product computations.

More than 600 economic indicators may be called up from the monthly business indicators (* 484846 #). The approx. 60 Btx pages are being updated immediately upon the availability of the most recent statistical figures. Calling up one table page costs DM 0.10.

Selected basic and structural data on more than 130 countries are offered on about 600 Btx pages under the headline **world in figures** (*4848480 #). There are provided 4 pages per country. Calling up one country costs DM 0.10.

It is further possible to order publications and to make brief inquiries by contacting the information service of the Federal Statistical Office. As a special Btx service, the press information service (*4848420 #) permits to order the current press releases.

The joint programme official statistics (*48481 #) is a guide to the information programmes of the statistical offices of the **Federation** and the **Laender**. It enables, among other things, to have direct access to Btx pages of the compendium of figures and corresponding Btx pages of the **Land** statistical offices, so that it is possible to call up comparable statistical results for the Federal Republic as a whole and the federal **Laender**. The programme is still being developed. Information material may be requested from the Federal Statistical Office.



The **Statistical Information System of the Federation (STATIS-BUND)** is available for the electronic processing of statistical results. Users may obtain data on data media or carry out statistical evaluations and mathematical-statistical analyses. In addition to the compilation of tables in the desired form, the system also makes possible special processings as well as the application of a great number of procedures of mathematical-statistical analysis. Users have the possibility of utilizing the information system either online or by placing an order with the Federal Statistical Office.



The fully documented stock of data which comprises at present about 500,000 time series is continuously being updated and extended. The data are available **online**, on **magnetic tape**, on **floppy disks** or as printouts. When ordering large quantities of data, preference should be given to magnetic tapes, while for smaller quantities or a specific selection of time series it will be advisable to use our new floppy

disk service. The information may be obtained either on a one-time basis or monthly, quarterly and semi-annually as part of an annual subscription.

A monthly business-line service of the Statistical Information System is available as a printed edition and – with a greater range of data and in a more detailed analysis of economic sectors – on floppy disks. The business-line service provides up-to-date figures on production, persons employed, turnover, prices and foreign trade. The editions of the business-line service can be ordered individually.

Online access to a selected part of the time series is also possible via the data processing installations and networks of commercial information providers. Detailed information on access procedures as well as costs may be obtained direct from the firms concerned.

free of charge. Against a nominal charge of DM 45.—, it is also possible to obtain from the Federal Statistical Office a catalogue containing about 1,600 definitions of statistical terms used in the Statistical Information System of the Federation (STATIS-BUND).



The **Library** of the Office has a stock of 396,000 volumes: apart from national and international statistical publications, in particular standard works on demography, economic and social sciences and environmental protection; 1550 current periodicals provide the most recent statistical data on these topics. There is the possibility of interlending via the central lending network file of scientific libraries in the data bank of periodicals.

For scientifically interested persons, the users' area including the reading room, online catalogue, information (tel. 0 61 21/75 24 60 or 75 20 69; area code from 5 September 1990: 06 11/) and issuing desk are open Monday through Friday from 8 a. m. to 3 p. m.
